Interview will begin at 9:00 a.m.

Pageant will begin at 6:30 p.m. line up begins at 5:30 p.m.

- Contestants must be single, may have never been married, never had a marriage annulled nor have children.
- Contestants will be judged on the following:
 - *Personality *Interview
 - *Charm *Beauty
 - *Health *Poise
- Any contestant that has competed on a professional level will be ineligible for this pageant (Professional is defined as: Any contestant that has performed or competed for monetary gain in anything other than amateur contest)
- Contestants must be 16 years of age by October 31st, 2017 and cannot have reached their 22th birthday by October 31, 2017 the year the pageant is held.
- Contestants must be the winner or runner up in the local contest in order to compete at the Kentucky State Fair. The contestant winner will become ineligible to participate in any other local contest. (Runner-up is accepted should for any reason the winner becomes ineligible or unable to attend the Kentucky Association of Fairs and Horse Shows). A contestant must represent the first fair that she wins first place in during that calendar year.
- Contestant interview appearance:
 - Each contestant will have a 5 minute interview
 - The dress code will be business attire
- **Contestant swimsuit appearance:**
 - Each contestant will show a **one piece swimsuit** on stage (“pageant swimsuit” is not necessary; however you will need one at the state level). The swimsuit may be based on personal taste however two-piece, French cut, mono-kini, keyholes or swimsuits with cut outs will not be allowed. High heels are recommended.
- **New Category** – Outfit of Choice – Contestants will compete in an outfit of choice, the 2017 theme for this category will be “A String of Pearls, A Black and White Event” Contestants will be encourage to wear an outfit that is representative of their personality and stays in the black and white color theme.
- Contestant evening dress appearance:
 - Contestants will be judged in evening gowns
- Contestants may have one (1) female adult assist them while preparing for the pageant- NO EXCEPTIONS
- NO cameras or recording devices are allowed in the dressing area
- Non-Contestants will be required to exit the dressing area when line up begins; at no time are parents, guardians, or person assisting a contestant allowed in the backstage area.
- Contestant is responsible for their clothing and personal items – Fair will not be held responsible

The winner will be expected to attend the following:

- The Kentucky State Fair in Louisville to compete on behalf of Henderson County in (registration for this event will be provided/ date to be announced)
- Henderson County Christmas Parade
- Friday July 21st and Saturday July 22nd 5:00 p.m. 7:30 p.m. Henderson County Fair
- Livestock awards on July 24th, July 25th, and 26th, 2017
- Contestant will be invited to participate at other events throughout the year however they are optional
