- Contestants will be judged on the following:
  - \*Personality      \*Interview
  - \*Charm            \*Beauty
  - \*Health            \*Poise
- Any contestant that has competed on a professional level will be ineligible for this pageant (Professional is defined as: Any contestant that has performed or competed for monetary gain in anything other than amateur contest)
- Contestants must have reached their 8<sup>th</sup> birthday by June 30<sup>th</sup>, and cannot have reached their 13<sup>th</sup> birthday by October 31 the year the pageant is held.
- Contestants must be the winner or runner up in the local contest in order to compete at the Kentucky State Fair. The contestant winner becomes ineligible to participate **in any other Kentucky County Fair Pageant.** (Runner-up is accepted should for any reason the winner becomes ineligible or unable to attend the Kentucky Association of Fairs and Horse Shows). A contestant must represent the first fair that she wins first place in during that calendar year.
- Contestant interview appearance:
- Each contestant will have a 5 minute interview
  - The dress code will be business attire
  - Contestant evening dress appearance:
    - Contestants should wear a pageant length dress however it must be age appropriate.
    - Example: crop tops or keyholes would not be appropriate in this age group
- Contestants may have one (1) female adult assist them while preparing for the pageant- NO EXCEPTIONS
- NO cameras or recording devices are allowed in the dressing area
- Non-Contestants will be required to exit the dressing area when line up begins; at no time are parents, guardians, or person assisting a contestant allowed in the backstage area.
- Contestant is responsible for their clothing and personal items – Fair will not be held responsible

The winner will be expected to attend the following:

- The Kentucky State Fair in Louisville to compete on behalf of Henderson County in (registration for this event will be provided/ date to be announced)
- Henderson County Christmas Parade
- Friday July 6th and Saturday July 7th 6:00 p.m. to 7:30 p.m. Henderson County Fair
- Livestock awards on July 21st 2018
- Contestants will be invited to participate at other events throughout the year however they are optional

- Second Place
- Miss Congenality

*Winners of the Miss Pre-Teen Henderson Pageant will be ineligible to compete in this category in the future.*
