General Information and Contract Agreement

Dead line for reservations July 18, 2017. If deadline is not met, we cannot guarantee space.

1. Book your space now! Booths are available on a first come first serve basis.
2. No repeat direct seller vendors. (Some exceptions apply, please email Charity Darling-Norman for details)
3. Six (6) vendor admission bracelets issued PER DAY and One (1) vehicle parking permit will be issued per booth rental. **NO EXCEPTIONS regarding the vehicle parking permit.**
4. Exhibitors are responsible for manning their booth during fair hours. No fire, flame grilling, or cooking permitted in your booth.
5. Check-in time for vendors will be Thursday from **NOON-4:00pm at GATE #3**. All vendors will enter and exit through **GATE #3**. You may not enter the fairgrounds without checking in and receiving your admission bracelets and vehicle permit.
6. Booth set-up available Thursday & Friday from NOON-4:30pm; Saturday from 7:00am-8:30am; Sunday 11:00am-12:30pm
7. ONE (1) vendor vehicle will be provided a vehicle parking permit. **Absolutely NO additional vendor vehicles are allowed on fairgrounds after 4:30pm.**
8. Please have your vendor vehicle parked in **designated vendor parking area no later than 4:45pm**. Make sure the issued VENDOR VEHICLE permit is clearly displayed on the dashboard showing your Booth#. Any vehicle parked in designated vendor parking area, **without** identifying permit will be towed at the owners' expense. **NO EXCEPTIONS.**
9. Exhibitor agrees to indemnify and hold harmless Henderson County Fiscal Court, Henderson County Parks & Recreation, Henderson County Fair Inc., and its members for any damages and/or liability arising out of injury, theft or personal property losses during said event.
10. Vendor booth space inside Exhibit Hall is limited. Outside booths have limited electricity, if any.
11. Please be responsible and keep your booth area clean and visually appealing!
12. Please make arrangements with any staff event personnel if you need help with restocking during fair hours. There will be contact numbers in your vendor packet for this purpose. We will be happy to work with you on this within reason. No vehicles will be allowed to drive inside fairgrounds during operating fair hours.
13. All vendors will enter and exit through GATE #3. NO vehicles without a vehicle permit will be allowed to enter fairgrounds during fair hours. **ABSOLUTELY NO EXCEPTIONS.**
